**HARRISON TOWN HALL**  
**August 12, 2024**  
**6:30 p.m.**

Meeting was called to order @ 6:30 p.m. by Chairman Hanson.

Members present: Chairman Hanson, Supervisor Daigle, Supervisor Goes, Clerk Voermans, Treasurer Boyle

Pledge of Allegiance was recited.

Recycling day brought in \$273.00. Another good day.

Chairman Hanson reminded everyone of the ordinance for the referendum to move to an appointed clerk rather than an elected one.

Motion by Chairman Hanson – 2<sup>nd</sup> by Supervisor Daigle to allow the town to rent Supervisor Goes skid steer when needed. Motion carried. Charge is \$75/hour.

Chairman Hanson gave an update on town land on Lower Long Lake Road. He will do some research on this.

Lawrence Schoone asked if the Harrison Hills ATV Club could use the town hall for a meeting on Monday, October 28<sup>th</sup>.

Motion by Chairman Hanson – 2<sup>nd</sup> by Supervisor Goes to allow ATV club to use hall. Motion carried.

Motion by Supervisor Daigle – 2<sup>nd</sup> by Supervisor Goes to put a Dead End sign just past Nubie Road on DeMeyer Road. Motion carried.

Supervisor Daigle stated the buoys are in on Pine Lake.

Items for next meeting's agenda – turn arounds/gravel ball park parking lot/move to appointed clerk/town land on Long Lake Road.
