

RESOLUTION NO. 2024-07
DeMeyer Road
Town of Harrison, Lincoln County, Wisconsin

WHEREAS, the Town of Harrison has investigated the history of DeMeyer Road in the Town of Harrison, Lincoln County, Wisconsin, including, but not limited to, review of all Highway Orders; Lincoln County Land Department records including Land Use Planning Maps; Wisconsin DOT Gas Tax records; Lincoln County Plat Books; Deed of ownership along DeMeyer Road; relevant Town of Harrison Monthly Minutes; discussions on Lincoln County records with the Lincoln County Surveyor, discussions with the owners of parcels on both sides of DeMeyer Road, discussions with historical Town of Harrison officials, and Release by Owner of Land signed by Joseph Renn and Henry Renn regarding the public road.

NOW THEREFORE, BE IT RESOLVED that the Board of Supervisors of the Town of Harrison, Lincoln County, Wisconsin, does hereby pass the following Resolution on this 8th day of July, 2024:

A. The Town of Harrison, upon investigation, determines that DeMeyer Road extends two (2) forties east of Nubie Road along the section line between Section 11 and Section 14, such road ending at the southwest corner of the Southwest Quarter Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$), Section 11, Township 34 North, Range 8 East.

B. The Town of Harrison finds the petition to discontinue part of DeMeyer Road presented to the Town of Harrison on February 13, 1990, does not comply with the requirements of § 82.10-82.12 and § 66.1003 Wis. Stats., or its predecessors, specifically noting that the requirements of a petition by six (6) or more resident freeholders, resolution by the Town Board, publication of a Class 3 public hearing notice, the holding of a public hearing, completion of a highway order, scale map, and filing of a lis pendens, were not met.


C. The Town of Harrison finds the eastern part of DeMeyer Road does not qualify for discontinuance of a highway under § 82.19, Wis. Stats., or its predecessor.

This Resolution may be recorded at the office of the Lincoln County Register of Deeds and relied upon by Wisconsin DOT for purposes of gas tax payments.

The foregoing Resolution was duly adopted by the Town Board of the Town of Harrison by a vote of 3 in favor and 0 against, on the 8th day of July, 2024.


